

## Rules and Procedures

1. The dance competition will conform to SOBHD rules and standards. The decision of the Judge(s) is final.
2. The dancers are required to have a 2010 registration cards.
3. Dancers will compete in their age groups according to their age on July 17, 2009.
4. The competition committee reserves the right to combine or divide classes depending upon entries received.
5. Dancers entering the competition first will dance last.
6. A trophy will be awarded to the highest aggregate point winner in each age group. No trophy for Primary.
7. Communication with the judge or piper regarding the competition, by the competitor or other interested parties is not allowed. This may result in disqualification.
8. Dancers must be ready and appear when called. Dancers failing to do so will forfeit their chance to dance in that event.
9. Dancers must be in costume to receive awards.
10. No field entries accepted.

**Saline, is located in southeastern Michigan, south of Ann Arbor. It is a short drive from I-94 and US 23.**

### **Recommended Route:**

US 23 to I-94 West to Exit 177 (State Street)  
Go south on State Street which becomes State Road. (3.5 miles) Turn right on East Michigan Ave. (US-12), 2.8 miles.

Parking is located at Liberty School or at the Saline Middle School.

Dancer drop on the festival grounds will be permitted only until 8:30 am.
